Step 1:

Next you will be asked to register your organisation, these details must match your details on any contracts with training providers.

NOTE - Please ensure your company name appears on the home screen. If it says 'My Account' amend it by clicking 'Settings' on the top right hand of the home page and click 'Change my account name'.



Step 9:

Enter your companies' house number, charity number or company name and select your organisation

If your company name doesn't appear you are able to search manually. Once found, click on company name and confirm details.

Step 10:

You will then be asked to enter a PAYE scheme. By agreeing you are granting authority for the Education and Skills Funding Agency to use your tax details.

Step 11:

Enter your Government Gateway login details which will pull through your PAYE scheme details.

Once you have set up your account you can then add more PAYE schemes if required (This is usually a PLC or group of connected companies that may need to add more PAYE schemes).

Finally, you will be asked if you would like to sign the Employer Apprenticeship Agreement* with the Education Skills Funding Agency. If you are not authorised by the company to sign official documents then this can be actioned at a later date, however, it must be done before any transfer payments can be made to training providers.
